I agree that any security interest granted to secure this loan should also collateralize any other indebtedness that I may now have or have in the future with the Credit Union including all debts incurred by credit cards and overdrafts. To secure the payment of this loan and all other indebtedness I owe or hereafter owe, whether or not said indebtedness was intended to be secured, I grant a security interest to the Credit Union in all assets of whatever nature and kind that are pledged hereby as collateral for the within indebtedness.
